6. Litter & Dog Waste Bins within the Parish

NW to review current bins and location within the Parish and report back; Due to issues with Vine Place and Dog Mess – Cllr NW looked into the possibility of having an additional waste bin but as this would incur additional costs it was decided to review existing provisions with the possibility of relocating an existing bin that maybe underused.

The Parish has a total of 49 Birs (38 litter & 11 Dog);

Par Beach – 20

Par Track – 9

Par village - 6

Duck Pond - 5

Tywardreath – 6

Misc location – 3

Although the beach has the highest no. of bins, there is still a visible issue with litter, NW to discuss with FOPB current locations.

Par Track has 9 bins however 3 of them are railing mounted and therefore not suitable for moving.

Par Duck Pond has 5 bins relatively close by to each other & could possibly lose 1, all other bins seemed in the right places.

One thing that was noticed on walking around the Parish was that the area with the most litter was around the Train Station where there are no bins.

Cllr NW to look further into options eg, ask the Train Station to put one in, move a bin and look at grants for litter awareness campaigns. If any?
