Fowey Hospital

20mph Limit in Tywardreath

I am pleased to report that Cornwall Council have agreed to install traffic speed surveys recording equipment in the village as a first stage in doing the technical preparation for the reduced speed limit.

1. Cllr Hughes tabled his resolution 'Tywardreath and Par Parish Council agrees to sign off on the draft Strategic Environmental Assessment (SEA) version of the Neighbourhood Development Plan for Tywardreath and Par Parish. This draft has been prepared for informal consultation with Cornwall Council officials.' This was seconded by Cllr Chamberlain and RESOLVED. 2. Cllr Phillips tabled his resolution 'Tywardreath and Par Parish Council agrees to appoint May, Whetter and Grose as sole agents to market the open space in the Par Beach toilet block.' This was seconded by Cllr A Wildish and RESOLVED.

19/134 Public Conveniences

The locking system of the ladies' toilet at Par Beach was still not working following public misuse. He was trying to source a key to lock the cubicle until repairs can be undertaken. Cllr Phillips reported that he had contacted the installers, Healthmatic, and they had requested photographs to enable them to assess the damage. Cllr Page agreed to supply these.

The PV installation at Par Beach had still not been commissioned but Cllr A Wildish was following up. Together with Cllr Page he would arrange for the company to attend the site and finalise the job.

19/138 Parish Council Notice Boards

Cllr Chamberlain suggested that the parish council could join with other councils to bulk buy systems, which would hopefully reduce the cost. Cllr Hughes proposed, Cllr Page seconded and it was RESOLVED that two signs should be purchased.

19/140 Budget 2020/2021

Cllr Phillips explained the reasoning behind the Finance Committees recommendations and supplied detail on budgeted figures and actual expenditure. He then proposed, Cllr Taylor seconded and it was RESOLVED that the precept for 2020/2021 should remain unchanged at £41,838.00.

19/141 Parish Councillors Reports

Cllr A Wildish had reported to Cornwall Council that the gulley's from Upper Polmear past the toilets needed clearing.

Rob Hamley and the team from Trenython had started work at the Treesmill triangle and it was looking very good. Thanks were due to him and also to Cllr Virr from both the parish council and the wider community

Cllr Page reported that a litter pick would take place on Sunday 15th December at Par Pond

Cllr Hughes noted that the mud on the Castledore Road was absolutely appalling. Additionally, the farmer had made an attempt to clear it with a loader causing damage to the road.

Cllr Chamberlain queried how much interest Cornwall Council had in Milo's and if the authority could influence how it operated. Cllr Hughes reported that he understood that there were conditions within Park Leisure's lease in respect of this and it was agreed that Cllr Rowse should be asked to investigate.
