I would like to thank the Council for agreeing to fund a programme of maintenance works. I have instructed Richard Heywood to start as soon as he is able and to start with the Plot at Upper Poldrea.

Sally has informed us that there are still outstanding rents for 1A, 1 and 2 Lower Poldrea, 1B Glenview and 7 Upper Poldrea, although she is still holding a random payment that presumably applies to one of them. Sally has asked that everyone support her with chasing these up, unfortunately I don't know them and have never seen any of them during my regular allotment visits.

Western Power have now completed work to cut back some trees which were hampering the Sub-Station at Woodland Avenue which has made the entrance much brighter.
