Minutes of a Meeting of Tywardreath & Par Parish Council Environment Committee held on Thursday 3rd February 2022

Present: Cllr Adrian Wildish (Acting Chairman), Cllr Louise Phillips, Cllr Craig Truscott, and Mr Kevin Rouse

22/01: Apologies Cllr Roy Taylor and Cllr Debrorah Hazledean

22/02: No declaration of interests, Pecuniary, non-registerable or dispensations

22/03: No Public Questions

22/04: Minutes of meeting held on 2nd December 2021

Proposed by CT seconded by LP and RESOLVED that these minutes be approved and signed by the Acting Chairman

22/05: Allotments

- KR reported there had been complaints of a rat infestation at Woodland Avenue and he asked the Allotment budget could be used towards dealing with them. AW ask KR to get the plot holders concerned to come up with an action plan for the committee to approve
- AW reported that on a site visit to Upper Poldrea chickens remained uncovered despite the current Bird Fly regulations. KR explained that signage had been placed at all the sites and a letter had been sent out by SV to the poultry owner but here had been a mix up with the plot numbers at Upper Poldrea, meaning the letter had gone out to the wrong person. This had now been rectified.
- AW as reported that a Restormel Council sign remained at Woodland Avenue which needs to be removed

22/06: Floral displays in Tywardreath and Par

- Well Street and the Butter Market planters were still being maintained by two ladies from the community . It was proposed by Cllr Phillips, seconded Cllr Wildish and RESOLVED that the parish council should finance plants for these locations on receipt of invoices.
- KR mentioned that he had heard a proposal to remove plant trees on Moorland Road. AW noted that neighbours may complain about shading in their gardens caused by the branches
- Planting of the red, white and blue Jubilee Flowers - LP suggested they could be planted going down Tehidy Road but a concern was that the farmer might strim them down whilst maintaining his hedges. It was also suggested that the Moorland Road Planters could be

used but a volunteer would need to be found to organise this. CT reported that SWW had recently dug up the corner of Poldrea and this was currently mud which could be used. LP also suggested the Treemill Triangle and possibly Polmear,

22/7: Weed Killing

- The Committee had been offered trees but since we have no land ourselves the offer was declined

- Loose Cobbles at the Butter Market - AW proposed, LP seconded and it was RESOLVED that Ollies Garden Maintenance be instructed to sort this out
- AW proposed, CT seconded and it was RESOLVED that the Butter Market Bench should be re-varnished and repainted
- KR mentioned the cracked paving at the WW1 bench at the bottom of Tehidy Hill, AW felt that this should be left at the moment as the paving was not currently loose
