22/01: Apologies

22/02: No declaration of interests, Pecuniary, non-registerable or dispensations

22/03: No Public Questions

22/04: Minutes of meeting held on 3rd February 2022 Proposed by CT seconded by LP and RESOLVED that these minutes be approved and signed by the Acting Chairman

22/05: Allotments

- KR reported that there were currently no issues to report
- KR confirmed he would begin getting quotes for the maintenance work needed this year
- AW asked if the Chickens were now correctly housed at LP following the Bird Flu regulations and CT agreed to go, look and report back

22/06: Floral displays in Tywardreath and Par

- RT asked for clarification regarding Cllr Virr's suggestion about planting trees on Moorland Road. AW explained that this had been discussed in February's EC meeting and the proposal was rejected. AW suggested that Cllr Virr have sight of the minutes for clarification
- WW1 at Tehidy Road AW agreed to try and source a contractor to look after this area
- Platinum Jubilee Red, White and blue seeds No areas have been designated yet but it was suggested that Sonia Clyne might be able to arrange for them to planted on the Moorland Road planters
- Butter Market Planters AW confirmed that these were owned by the County Council and he would contact John Page about who had been looking after them

22/7: Weed Killing

22/8: Local Maintenance Partnership

22/9: Climate Change

- DH has produced a lengthy and comprehensive report which she has forwarded to all Cllr's she has asked for feedback to support this.
- LP said she would use her experience of farming to help the local parishioners as needed
- AW has agreed to look into organising a poll on the TPPC website and also a gazebo with further information during Par Carnival week
- DH also suggested that a student intern might be interested in helping set a website up as part of their course and she would investigate this further
- AW has confirmed any final actions would need to be agreed by the full Parish Council before going ahead.
