22/01 Election of the Chairman - RT proposed DH seconded LP, RESOLVED

22/02: Apologies - None

22/04: Public Questions - A member of the public asked where the benches had gone from Par Green and Eastcliffe Road and LP also mentioned the bench at Lanescot turning had been removed.

22/0: Allotments

- KR reported that TAS had arranged Community Chest funding for a small orchard to be planted at the Woodland Avenue to commemorate the Queen's Platinum Jubilee and 3 Cornish Heritage Apple trees had been planted
- KR and CT arranged to complete the plot inspections on 17th July
- KR reported that a plot holder at Lower Poldrea is having trouble maintaining the main access pathway by herself because there were so many untended plots. LP proposed a twice yearly strim of the pathway to be completed by Ollie Garden Maintenance Seconded by RT. RESOLVED.

- KR reported that Ocean Housing has put up a chain link fence which has encroached on the allotment site. This has also blocked the pedestrian access to the site and they have not rehung the gate properly making it unusable.
