#### 22/53 Planning Applications

1. PA22/09987. Erection of domestic garage and store without compliance with condition 2 of decision notice C2/97/00967 dated 03/09/1997. Marshyest, 9, Well Street, Tywardreath, PL24 2QH. Members noted that the proposal would have no significant impact on neighbours or public views, nor create any increase in traffic. It was proposed by Cllr Phillips, seconded by Cllr C Wildish and RESOLVED that a recommendation of no objection should be made to Cornwall Council, but as the proposal is to convert from a garage to habitable rooms, conversion should comply with relevant building regulations, in particular with respect to energy conservation. Also, given the nature of the site, any permission should specify that it should only be used as an ancillary accommodation to the existing premises, with any conversion to an independent dwelling specifically precluded.

2. PA22/09687. Retention of agricultural/events buildings with associated parking. James Kittow, Butcher and Grazier, The Events Centre, Kilhallon Farm, Kilhallon Par, PL24 2RL. It was proposed by Cllr Hughes, seconded by Cllr A Wildish and RESOLVED that a recommendation of no objection should be made to Cornwall Council, noting that the applicant was seeking to regularise an existing use with no

physical changes to the status quo and that the current activity fulfils an educational and social function of benefit to the wider community.
