- 1. PA25/01228. Removal of Stone Wall and Installation of Drop Kerb to Provide Access for Off-Street Parking. 106, Par Green, Par, PL24 2AG. It was proposed by Cllr A Wildish, seconded Cllr Phillips and RESOLVED that a recommendation of no objection should be made to Cornwall Council.
- 2. PA25/01832. Proposed ground floor extension, modifications and improvements. Tyward House, Par, PL24 2RX. Cllr Hughes noted that this proposal would have no significant impact on public views or on the setting of the Grade 2 Listed Austen Engine House (400m NW). It was proposed by Cllr Hughes, seconded Cllr C Wildish and RESOLVED that a recommendation of no objection should be made to Cornwall Council.
- 3. PA25/01783. Change of use from mixed use (restaurant and micro-brewery) to a veterinary clinic (Class E). Howl Dowr, Polmear Hill, Par, PL24 2AR. Members noted that there would be no significant impact on neighbours or public views; this would be a useful local facility offering employment opportunities in a sustainable location. There had been no objection from Environment or Flood Authority and the proposal was in line with the objectives of the Tywardreath & Par NDP and the CLP. It was proposed by Cllr Truscott, seconded Cllr Phillips and RESOLVED that a recommendation of no objection should be made to Cornwall Council

4. PA24/09645. Listed Building Consent to grant approval for a new swimming pool and to adapt an adjacent existing temporary structure into a family gym/pool house. Great Treverran, Par, PL24 2TZ. Members noted that this proposal would have no significant impact on neighbours or public views nor on the setting of the Grade 2 Listed Great Treverran House.
