15/16 Par Pay Skatepark Project

Cllr Tayor and Cllr Wildish had attended a recent meeting. The SK8 group was working on the grant application.

15/17 Public Conveniences

The Clerk had been contacted by Jonny Alford earlier in the day as he was keen to progress the transfer. The proposed Overage would be the same as the amended one negotiated by FTC. Members confirmed that they wished full searches to be commissioned. The Clerk confirmed that the Fowey Town Quay toilet refurbishments had been completed and the toilets were open to the public but she cautioned members that there was a significant amount of work involved both during the refurbishment and in the day to day running of the facilities.

15/18 Neighbourhood Plan

No update.

15/19 Tywardreath Allotments

Cllr Hughes reported that he had been contacted by somebody living on Mount Bennett Terrace who had reported that somebody from Cornwall Council Property Services had been taking photographs in connection with putting a value on the site in front of their properties. He would monitor the situation but understood that there was currently no suggestion that the site would be sold.

15/20 Play Area

Cllr Phillips noted that it appeared that Cornwall Council was looking to transfer the approach road with the play area. Cllr Scrafton responded that he did not think this was the case as CC had a legal responsibility to provide access to the caravan park. It was agreed that the Clerk should confirm that the proposed area to be transferred was correct but that the position in respect of the road should be clarified.

15/21 Parish Councillors Reports

Cllr Hughes and Cllr Scrafton had attended the first ever Cornwall Civic Awards ceremony at County Hall the previous week. Both Malcolm Bowers and Sonia Clyne had received an award.

Cllr Hughes reported that at last weeks Cabinet meeting the sale of the two county farms at Higher and Lower Lampetho had been raised in the public session. It had been agreed that both properties could be sold but the tenants best interests would be safeguarded.

Cllr Scrafton reported that Cormac had been working to improve the surface of Par Beach car park. Also, following an instruction from Bert Biscoe, the possibility of a more permanent surface would be investigated. The potholes in the approach road were due to be repaired.

Cllr Scrafton reported that he was still receiving complaints about the state of the footpath along the Par railway track

Cllr Taylor reported that he had requested a litter pick in Tywardreath Highway and Penpillick Hill, which had been carried out.

Cllr Waddington reported Japanese Knotweed in the field at the rear of Par Green and voiced concern that it could spread into private gardens. Cllr Hughes urged as many people as possible to lodge complaints with Cornwall Council.

Cllr Phillips noted that the website needed updating to show the current Councillors.

Cllr Phillips noted that more signatories were needed for the parish council bank accounts.
