The Parish Clerk reported that Cllr Fowler had verbally submitted his resignation from the parish council.

There had been 9 recorded crimes in December – 1 x violence with injury, 1 x violence without injury, 1 x other sexual offence, 1 x robbery, 1 x vehicle offence, 1 x other theft, 3 x shoplifting and 23 police incidents recorded.

#### **16/139 Minutes of the Meeting held on the 1<sup>st</sup> December 2016**

16/120. Cllr Wildish noted that it was Charles Richards, not Charles Retallack, who was stepping down from the Flood Group Emergency Committee. With this amendment it was proposed by Cllr Scrafton, seconded Cllr Phillips and RESOLVED that the minutes be confirmed and signed by the Chairman.

#### **16/140 Matters arising not on the agenda (for report only)**

1. Par Beach Public Conveniences. The Clerk reported that the outer locking padlock and bar system to the coin pay machines had been vandalised but this had not allowed access to the machines themselves, which were completely secure.
2. FOPB had asked if it would be possible for them to use the empty space behind the toilets for storage of their equipment as they had been told to

move it from Cornubia Hall. The general feeling was that the parish council must have an income from the space to contribute towards the maintenance of the toilets. It was agreed that this should be an agenda item in February.

### **16/141 To receive the Cornwall Councillors reports**

#### **Cllr Scrafton – reported**

- I have attended a number of meetings, including the Par Beach Management Committee, the Localism and Economy and Culture Policy Advisory Committees, a meeting of the Corserv Board and an all member briefing on the implications of withdrawal from the European Union.
- The resurfacing of Par Green is to proceed next week. The closure of Par Green from 0930 to 1630, and the suspension of one-way traffic in Eastcliffe Road, to which I referred in my report last month, will go ahead. There will in addition be a one-night closure of Par Green on 10<sup>th</sup>/11<sup>th</sup> January, when Network Rail will be undertaking work on the railway bridge.
- I have also received notification of an intention to close the access road to Par Beach that runs down the side of the nail bar from 19<sup>th</sup> to 25<sup>th</sup> January. That closure is still open for consultation and comments.
- South West Water have promised me a meeting about their proposal to ship untreated waste by tanker from the Pentewan sewage works to the one on Par Moor Road. This has been prompted by the concerns of residents and visitors to Pentewan about the smell. I have already made clear to SWW that the residents of Par also have active olfactory organs.
- Roy Taylor and I have both registered our strong objection to proposals by Cornwall Council to introduce an evening parking charge at Par Beach. The proposal is for a £1 charge for parking between 5pm and 11pm. This, we have argued, would be quite unfair to local people who enjoy walking their dogs along the beach in the evening. Moreover, it is a nonsense that someone who parks for an hour after 5pm should be charged more than someone parking for an hour during the day.

#### **Cllr Taylor – reported**

- The foliage growing across the pavement from the base of the hedge beside the A390 between Santos Terrace and Hillside has been cut back by Cormac at my request. (Ownership as I am informed is unknown despite a fairly recent failed planning application for development of the site).
- I have mediated an agreement between two neighbouring landowners who were in disagreement over the height of a hedge. Compromise saved the day.
- A litter pick has been requested and carried out along Tywardreath Highway. Leaf litter clearance from Kilhallon Lane and Kilhallon Woodlands pavements has also been requested.

Cllr Wildish reported that, together with Cllr Taylor, she had attended the scheduled meeting in December but very little had been achieved, although Charles had repeated his wish to step back from the Committee. The next meeting was scheduled for 20<sup>th</sup> January when hopefully the situation would become clearer. Cllr Wildish repeated her offer to write an Emergency Plan for Tywardreath & Par as this was something she did regularly on a professional basis.

Cllr Wildish reminded the meeting that this appointment would only be short-term, due to the May 2017 elections. Cllr Scrafton noted that the age demographic was certainly in Jordan Rowse's favour and that for that reason alone, although also for many others, he proposed, Cllr Phillips seconded and it was **RESOLVED** that Jordan should be co-opted on to the parish council.
