 PA18/04720. Notification of proposed works to trees in a conservation area -Felling of a Blue Gum Eucalyptus Globulus (T10) and a Betula Pendula (T9). Tywardreath School Southpark Road Tywardreath. It was proposed by Cllr Hughes, seconded Cllr Rowse and RESOLVED that a recommendation of no objection should be made to Cornwall Council, although noting that it was extremely unfortunate to lose such a splendid tree.

Application for approval of reserved matters, appearance, landscaping, layout and scale following outline approval PA17/02450 (Variation of Condition 1 in respect of decision PA16/11537 dated 20.02.17 for outline planning permission with some matters reserved for development of up to 8 self-build dwellings). Land South West of Hillbrough, Porcupine Road, Porcupine, Par It was proposed by Cllr Phillips, seconded Cllr Wildish and RESOLVED that a recommendation of no objection should be made to Cornwall Council

It was proposed by Cllr Phillips, seconded Cllr Hughes and RESOLVED that a recommendation of no objection should be made to Cornwall Council | 5. PA18/04813. Extension to rear of dwelling to provide en-suite room and dressing rooms. 2 Trevance Park Tywardreath. It was proposed by Cllr Hughes, seconded Cllr Wildish and RESOLVED that a recommendation of support should be made to Cornwall Council *Reason: This proposal would significantly enhance a modest property and would have no significant impact on neighbours or public views*

6. PA18/05048. Erection of single storey rear extension with roof terrace above. 88 Polmear Parc Par. It was proposed by Cllr Shroff, seconded Cllr Phillips and RESOLVED that a recommendation of objection should be made to Cornwall *Reason: Whilst the parish council had no objection in principle to a modest balcony, a roof terrace on the scale proposed would interfere with the amenities of neighbouring properties, in particular in relation to the potential of noise nuisance.*

7. PA18/05316. Application for works to a tree subject to a tree preservation order (TPO) Monterey Pine needs felling. Pine Trees Kilhallon Par. It was proposed by Cllr Hughes, seconded Cllr Rowse and RESOLVED that a recommendation of

objection should be made to Cornwall Council *Reason: As the house name implies, these trees are an important and longstanding part of the landscape, which should be preserved unless serious, professionally supported, safety arguments are presented. No formal arboricultural statement is attached to the application.*
